### Explanatory Notes

1. Private hospital  
Refers to Private institutions licensed under the Hospitals, Nursing Homes and Maternity Homes Registration Ordinance (Chapter 165).
2. Self-employed / Employer  
Self-employed refers to the one works for himself or herself and is not employed as an employee. If you are a sole proprietor or partner of a partnership of a business, you will be regarded as self-employed.  
An employer refers to a person who has entered into a contract of employment to employ another person as his employee.
3. Basic qualification in radiography profession  
Refers to the minimum entry qualification to the radiography profession.
4. Additional training  
Relevant medical and health training obtained from recognized institutions in addition to the basic qualification. **In-house training or short courses with certificate of attendance/achievement issued only should not be considered as additional training.**

### Statement of Purposes

#### Purpose of Collection

1. #### Classes of Transferees

Only aggregate information and not details of individual personnel will be released to other government bureaux / departments, agencies or authorities for the purposes mentioned in paragraph 1 above, if required. Apart from this, your personal information provided by means of this survey will only be disclosed to parties where you have given consent to such disclosure or where such disclosure is allowed under the Personal Data (Privacy) Ordinance.

#### Access to Personal Data

3. You have a right of access and correction with respect to personal data as provided for in sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance.
