

2007 Health Manpower Survey on Occupational Therapists 2007 年有關職業治療師的醫療衛生服務人力統計調查

Key Findings

結果摘要

- The occupational therapists covered in the 2007 HMS were occupational therapists registered with the Occupational Therapists Board of Hong Kong under the Supplementary Medical Professions Ordinance (Chapter 359) as at the survey reference date i.e. 31.3.2007.
 - The number of occupational therapists covered in the 2007 HMS was 1 213.
 - Of the 1 213 registered occupational therapists covered, 750 had responded to the Survey, giving an overall response rate of 61.8%. As at 31.3.2007, 689 of the responding occupational therapists were economically active*† (active) while 61 reported to be economically inactive*‡ (inactive) in the local occupational therapy profession (See Chart).
 - Of the 689 active occupational therapists, 681 were practising in the local occupational therapy profession, five were seeking jobs, and three were waiting to take up new job or believed that no work was available in the occupational therapy profession during the 30 days before the Survey.
 - The survey findings presented below were based on the 681 responding occupational therapists who were practising in the local occupational therapy profession as at 31.3.2007. As some questionnaires contained missing information, percentages presented below may not add up to 100%.
 - (i) One occupational therapist did not indicate their sex. Among the remaining 680 active occupational therapists enumerated, 193 (28.4%) were male and 487 (71.6%) were female, giving an overall sex ratio of 40 (males per 100 females). 17 occupational therapists did not indicate their age. The median age of the remaining 664 active occupational therapists enumerated was 34.0 years.
 - (ii) Distribution by sector of the main job§ showed that about half of the active occupational therapists enumerated were working in the Hospital Authority (48.0%), 35.1% were working in the subvented sector, 8.5% in the private sector, 5.9% in the academic sector and 2.5% in the Government.
 - (iii) Of the 681 active occupational therapists enumerated, 87.7% spent most of their working time in rehabilitation. Those who spent most of the working time in administration / management and teaching attributed to 8.5% and 1.6% respectively.
- 2007 年的醫療衛生服務人力統計調查，涵蓋截至調查點算當日(即 2007 年 3 月 31 日)已根據《輔助醫療業條例》(第 359 章)的規定向香港職業治療師管理委員會註冊的職業治療師。
 - 2007 年的醫療衛生服務人力統計調查所涵蓋職業治療師的人數為 1 213 名。
 - 在統計調查所涵蓋的 1 213 名註冊職業治療師中，有 750 名作出回應，整體回應率為 61.8%。在回應者中，有 689 名職業治療師於 2007 年 3 月 31 日在本港職業治療專業從事經濟活動*† (在職)，有 61 名據報並非在本港職業治療專業從事經濟活動*‡ (非在本港從事業內工作)(見圖)。
 - 在 689 名在職職業治療師中，681 名在本港從事職業治療專業工作，5 名在統計日前 30 天內正在找尋職業治療專業工作，另有 3 名職業治療師在統計日前 30 天正等待上任新的職業治療專業工作或相信職業治療專業工作暫無空缺。
 - 下文所載的統計調查結果，是根據 681 名於 2007 年 3 月 31 日在本港從事職業治療專業的職業治療師所提供的資料而製備的。由於部分問卷資料不全，下文所載的百分比總和可能不等於 100%。
 - (i) 1 名職業治療師沒有註明性別，在餘下 680 名經點算在職職業治療師中，男性佔 193 名 (28.4%)，女性佔 487 名 (71.6%)，整體性別比率為 40 (每百名女性的男性人數)。17 名職業治療師沒有註明年齡，而餘下 664 名經點算在職職業治療師的整體年齡中位數為 34.0 歲。
 - (ii) 按主要職位§所屬機構類型劃分的分布資料顯示，在經點算在職職業治療師當中，約有一半 (48.0%) 在醫院管理局工作，其餘依為資助機構 (35.1%)、私營機構 (8.5%)、學術機構 (5.9%) 及政府 (2.5%)。
 - (iii) 在 681 名在職職業治療師中，87.7% 把大部分工作時間用於康復治療。把大部分工作時間用於行政／管理及用於教學的分別佔 8.5% 及 1.6%。

* In the Survey, the criteria used in defining economically active / inactive followed those recommended by the International Labour Organization, which are also being used by the Census and Statistics Department in Hong Kong.

† “Economically active” occupational therapists comprised all “employed” and “unemployed” occupational therapists. “Employed” occupational therapists referred to those occupational therapists practising in the occupational therapy profession in Hong Kong during the Survey period, while “unemployed” occupational therapists referred to those occupational therapists who (a) were not practising in the occupational therapy profession during the Survey period; (b) had been available for work during the seven days before the Survey; and (c) had sought work in the occupational therapy profession during the 30 days before the Survey.

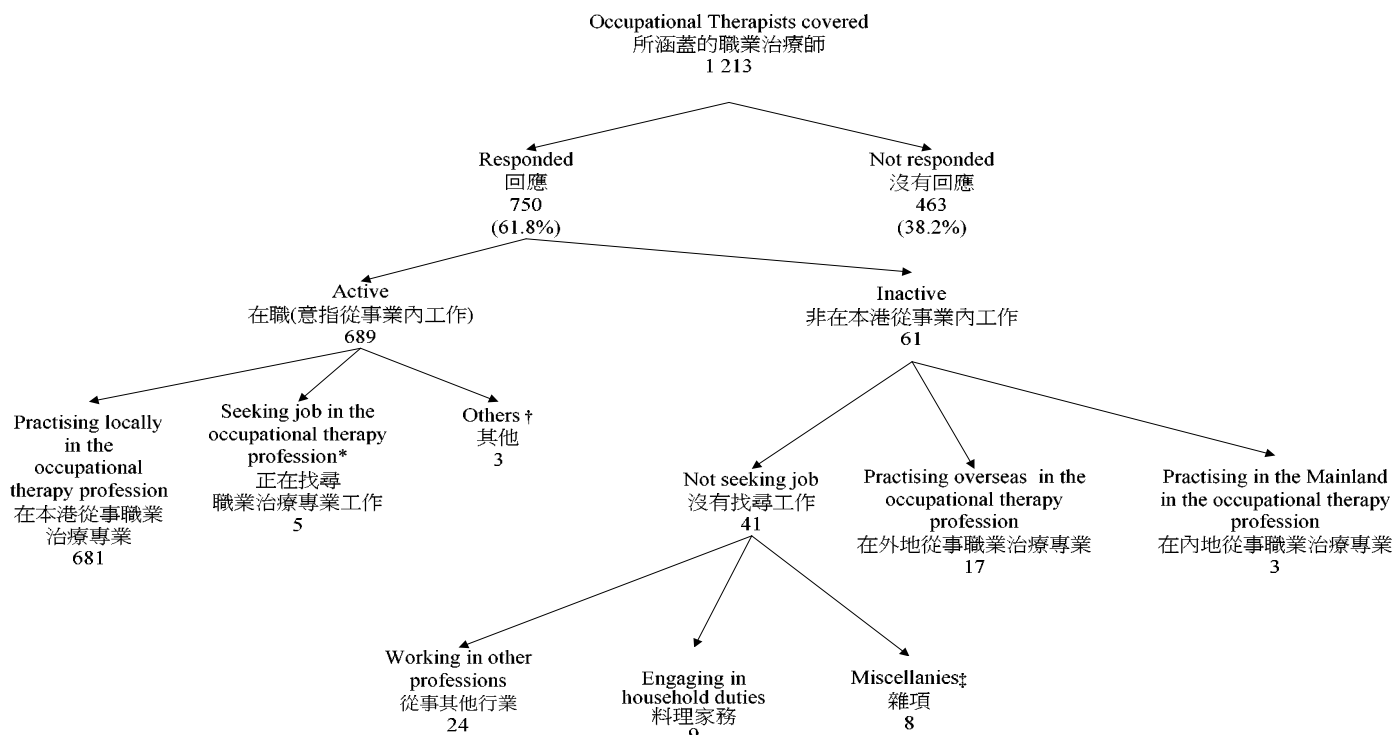
‡ “Economically inactive” occupational therapists comprised the occupational therapists who were not practising in the occupational therapy profession in Hong Kong during the Survey period, but excluding those who had been on leave during the Survey period and who were “unemployed”. “非從事經濟活動”的職業治療師包括在統計調查期間並非在本港從事職業治療專業的職業治療師，但不包括在統計調查期間休假期及“待業”的職業治療師。

§ Main jobs referred to the jobs in which the occupational therapists had spent most of their working time.

主要職位是指佔職業治療師大部分工作時間的職位。

- (iv) The median hours of work (excluding meal breaks) per week of the 681 active occupational therapists enumerated was 44.0 hours. 33 (4.8%) occupational therapists were required to undertake on-call duty in their posts, with a median of 4.0 hours of on-call duty (excluding normal duty) per week.
- (iv) 經點算的681名在職職業治療師每週工作時數中位數(不計用膳時間)為44.0小時。33名(4.8%)職業治療師在現任職位中須擔任隨時候召工作。他們的每週隨時候召工作時數中位數(不計日常職務時間)為4.0小時。
- Among the 61 inactive occupational therapists (*See Chart*):-
- (i) 17 occupational therapists reported practising overseas and three reported practising in the Mainland.
- (i) 17名職業治療師據報在外地，另有3名在內地執業。
- (ii) 41 occupational therapists reported not practising in the occupational therapy profession in Hong Kong and not seeking job in the occupational therapy profession during the 30 days before the Survey. The reasons reported for not seeking job included: working in other professions (58.5%) and engaging in household duties (22.0%).
- (ii) 41名職業治療師據報並非在本港從事職業治療專業工作，而在統計日前30天內亦無找尋業內工作。這些職業治療師當中，沒有找尋業內工作的原因包括：從事其他行業(58.5%)及料理家務(22.0%)。
