Executive Summary

I. Dentists Covered

- 1.1 The dentists covered in the 2007 HMS were dentists registered with the Dental Council of Hong Kong on the list* of registered dentists resident in Hong Kong under the Dentists Registration Ordinance (Chapter 156) as at the survey reference date 31.8.2007.
- 1.2 The number of dentists covered was 1 838.
- 1.3 Of the 1 838 dentists covered, 1 152 had responded to the survey, giving an overall response rate of 62.7%. Among the respondents, 1 092 were economically active^{†‡}(active) in the local dental profession as at 31.8.2007 and 60 reported to be economically inactive^{† §} (inactive) (**Chart A**).

簡要報告

I. 所涵蓋的牙醫

- 1.1 2007 年醫療衞生服務人力統計調查,是指截至調查點算當日(即 2007 年 8 月 31 日)已按《牙醫註冊條例》(第 156 章)的規定,向香港牙醫管理委員會備存的牙醫本地名單*註冊的牙醫。
- 1.2 所涵蓋牙醫的人數爲 1838 名。
- 1.3 在統計調查所涵蓋的 1 838 名牙醫中,有 1 152 名作出回應,整體回應率為 62.7%。在回應者中,有 1 092 名牙醫於 2007 年 8 月 31 日在本港牙科醫學專業從事經濟活動^{†‡}(在職),而有 60 名據報並非在本港牙科醫學專業從事經濟活動^{†‡}(非在本港從事業內工作)(圖甲)。



- 1.4 Of the 1 092 active dentists, 1 081 were practising in the dental profession, six were seeking jobs and five were starting business at subsequent date or waiting to take up new job in the local dental profession during the 30 days before the survey. The survey results presented in paragraph 1.6 below were based on the responding dentists who were practising in the local dental profession as at 31.8.2007. As certain questionnaires contained missing information, percentages presented below may not add up to 100%.
- 1.5 Of the 60 inactive dentists, 29 reported practising overseas or in the Mainland. There were 28 reported not practising in the dental profession in Hong Kong and not seeking job in the local dental profession during the 30 days before the survey (Chart A). The main reasons included: (53.6%) were retired. 15 six (21.4%) were working in other professions and four (14.3%) wanted to take rest/having no motive to work/having no financial need, etc.
- 1.4 在 1 092 名在職牙醫中,有 1 081 名 正在本港從事牙科醫學專業、六名正在找尋 牙科醫學專業工作、五名即將開展牙科醫學 專業的生意或等待上任新的牙科醫學專業 工作。下文第 1.6 段所載的統計調查結果, 是根據 1 081 名於 2007 年 8 月 31 日在本港 從事牙科醫學專業的牙醫所提供的資料而 製備的。由於部分問卷資料不全,下文所載 的百分比總和可能不等於 100%。
- 1.5 在 60 名非在本港從事業內工作的牙醫中,29 名據報在外地或內地執業。28 名非在本港從事牙科醫學專業,在統計日前30 天內亦無找尋業內工作(圖甲)。當中主要原因包括:15 (53.6%)退休、六名(21.4%)從事其他行業及四名(14.3%)希望休息/不想工作/財政上沒有需要等項目。

尋牙科醫學專業工作的牙醫人數

- 1.6 Of the 1 081 active dentists enumerated, 787 (72.8%) were male and 294 (27.2%) were female, giving an overall sex ratio (males per 100 females) of 268. The median age of the active dentists enumerated was 43.0 years. The median age of the active female dentists enumerated was 36.0 years and that of their male counterparts was 44.0 years.
- The responding active dentists were 1.7 requested to indicate the characteristics of their main jobs*. Distribution by sector showed that a large proportion of the active dentists enumerated were working in the private sector (73.5%), followed by those working in the Government (17.6%), the academic[†] sector (5.7%) and the subvented sector (2.5%). Among the 794 active dentists enumerated who were working in the private sector, the largest proportion (65.2%) were in solo practice, followed by group practice (32.6%) and other private institutions (2.1%).
- 1.8 The median age of the active dentists enumerated was 44.0 years for those working in the private sector, followed by 41.0 years for those working in the Government, 39.0 years for those working in the academic sector or in the Hospital Authority and 36.0 years for those working in the subvented sector.
- 1.9 Of the 1 081 active dentists enumerated, 86.0% spent most of their working time on general dentistry, followed by specialist practice (10.5%), teaching / education (1.8%) and administration / management (1.0%).

- 1.6 經點算的 1 081 名在職牙醫當中, 男 性 佔 787 名 (72.8%) , 女 性 佔 294 名 (27.2%),整體性別比率(每百名女性 的男性人數)爲 268。經點算在職牙醫的整體 年齡中位數爲 43.0 歲。經點算女牙醫的年 齡 中位數爲 36.0 歲,而男牙醫的則爲 44.0 歲。
- 1.7 我們要求作出回應的在職牙醫填寫 其主要職位*的特徵。按主要職位所屬機構 類型劃分的分布資料顯示,大部分經點算在 職牙醫在私營機構工作(73.5%),其餘依次 爲政府(17.6%)、學術機構[†](5.7%)和資助機 構(2.5%)。在794名經點算私營機構工作的 在職牙醫中,大部分(65.2%)爲獨自執業, 其次爲聯合執業(32.6%)及其他私營機構執 業(2.1%)。

- 1.8 經點算任職私營機構的在職牙醫的年齡中位數爲 44.0 歲,其餘依次爲政府 (41.0 歲)、學術機構或醫院管理局 (39.0 歲)及資助機構(36.0 歲)。
- 1.9 在 1 081 名經點算在職牙醫中,86.0%把大部分工作時間用於牙科全科,其餘依次爲專科執業(10.5%)、教學/教育(1.8%)及行政/管理(1.0%)。

- 1.10 The median number of hours of work (excluding meal breaks) per week of the 1 081 active dentists enumerated was 44.0 hours. 75 (6.9%) active dentists had to undertake on-call duty, with a median of 8.0 hours of on-call duty (outside normal working hours) per week.
- 1.11 Regarding the average number of consultations / patients encountered per working day, 48.5% of the active dentists enumerated reported a range of 11 to 20, 34.9% reported as 10 consultations / patients or below and 14.1% reported as more than 20 consultations / patients encountered per working day.
- 1.12 Of the 1 081 active dentists enumerated, 63.1% held Bachelor's degree obtained in Hong Kong as their basic qualification, 24.2% held Bachelor's degree and 11.9% held Doctoral degree issued by overseas institutions as their basic qualifications.
- 1.13 Of the 1 081 active dentists enumerated, 426 (39.4%) had obtained additional qualification(s), 652 (60.3%) did not obtain any additional qualification, and three (0.3%) did not reveal whether they had obtained additional qualification or not. Of the 426 dentists with additional qualification(s), 224 (52.6%) had obtained one additional qualification. Among them, 68 (30.4%) had obtained Master's degree and 50 (22.3%) had obtained fellowship and 45(20.1%) had obtained post-graduate diploma as their additional qualifications.
- 1.14 Of the 426 active dentists who had obtained additional qualification(s), 362 (85.0%) had obtained additional qualification in one field. Among them, 35.9% were in general dentistry, 12.2% in prosthodontics, 11.9% in orthodontics and 9.7% in oral and maxillofacial surgery.

- 1.10 經點算的 1 081 名在職牙醫每週工作時數中位數(不計用膳時間)為 44.0 小時。75 名(6.9%)牙醫需擔任隨時候召的工作,而每週隨時候召工作(不計日常職務時間)時數的中位數為 8.0 小時。
- 1.11 至於每天的平均診症次數/病人人數,48.5%經點算在職牙醫填報每工作天介乎 11 至 20 人次,34.9%填報少於或等於10 人次及 14.1%填報多於 20 人次。
- 1.12 在 1 081 名經點算在職牙醫中,以本港受訓並持有學士學位(63.1%)作爲基本資格的人數最多,24.2%則持有海外機構頒授的學士學位以及 11.9%持有海外機構頒授博士學位作爲基本資格。
- 1.13 在 1 081 名經點算在職牙醫中,426 名(39.4%)持有額外資格。652 名(60.3%)沒有持有額外資格及三名(0.3%)則沒有註明曾否獲得額外資格。在 426 名持有額外資格的牙醫當中,224 名(52.6%)持有一項額外資格,當中 68 名(30.4%)獲得碩士學位、50 名(22.3%)獲得院士、45 名(20.1%)獲得深造文憑爲額外資格。

1.14 在 426 名持有額外資格的經點算在職牙醫中,362 名(85.0%)持有一項額外資格;當中 35.9%爲牙科全科、12.2%爲修復齒科、11.9%爲牙齒矯正科及 9.7%爲口腔頜面外科。

- 1.15 Regarding Continuing Medical Education (CME) training, 950 (87.9%) active dentists revealed that they had participated in CME training in 2007, 117 (10.8%) did not participate in any CME and 14 (1.3%) did not reveal whether they had participated in CME training or not. Among the 950 active dentists who had participated in **CME** training, distribution of CME points received in the past 12 months was: more than 20 points (61.4%), 16 to 20 points (14.1%), 11 to 15 points (10.0%), 6 to 10 points (6.6%) and 1 to 5 points (7.9%).
- 1.15 關於在職牙醫的持續醫學教育,950名(87.9%)在職牙醫表示2007年曾參與有關持續醫學教育,117名(10.8%)表示沒有參加任何有關持續醫學教育及14名(1.3%)沒有註明曾否接受有關持續醫學教育。950名至於表示曾參與有關活動的在職牙醫中,在過去12個月所獲得的學分爲:20學分以上(61.4%),16至20學分(14.1%),11至15學分(10.0%),6至10學分(6.6%)及1至5學分(7.9%)。

II. Trend Analysis

- 2.1 Comparison of findings of the 2007 HMS with those surveys before 2003 should be cautious as the survey methodology and reference date had been changed (**Chart B**).
- 2.2 Between 1982 and 2007, the number of dentists increased from 747 to 1 838.

II. 趨勢分析

- 2.1 由於 2007 年所用的統計調查方法及 點算日均已改變,故與 2003 年以前的統計 調查結果比較時必須小心謹慎(**圖乙**)。
- 2.2 在 1982 年至 2007 年期間,牙醫人數 由 747 名上升至 1 838 名。


Chart B: Number of Dentists Covered by Year (1982, 1984, 1987, 1990, 1992,

- 2.3 A decreasing trend was observed in the proportion of male dentists, as indicated by a continuous decrease in the overall sex ratio (males per 100 females) from 679 (males per 100 females) in 1982 to 268 (males per 100 females) in 2007 (**Table A**).
- 2.3 整體性別比率(每百名女性的男性人數)由 1982 年所得的 679(每百名女性的男性人數),持續下跌至 2007 年所得的 268(每百名女性的男性人數),顯示男性牙醫的比例有下降趨勢(表甲)。
