# 2005 Health Manpower Survey 2005 年醫療衞生服務人力統計調查 Summary of the Characteristics of Optometrists Enumerated 經點算視光師的特徵摘要

## I. Optometrists Covered

- 1.1 The optometrists covered in the 2005 HMS were optometrists registered with the Optometrists Board of Hong Kong under the Supplementary Medical Professions Ordinance (Chapter 359) as at the survey reference date 31.3.2005.
- 1.2 The number of optometrists covered was 1 898.
- 1.3 Of the 1 898 registered optometrists covered, 1 353 had responded to the survey, giving an overall response rate of 71.3%. Among the respondents, 1 304 were economically active\* (active) in the local optometry profession as at 31.3.2005 whereas 48 reported to be economically inactive\* (inactive) (Chart A).

### I. 所涵蓋的視光師

- 1.1 2005 年的醫療衞生服務人力統計調查所涵蓋的視光師,是指截至調查點算當日(即 2005 年 3 月 31 日)已按《輔助醫療業條例》(第 359 章)的規定,向香港視光師管理委員會註冊的視光師。
- 1.2 所涵蓋視光師的人數為 1898 名。
- 1.3 在統計調查所涵蓋的 1 898 名註冊視 光師中,有 1 353 名作出回應,整體回應率 為 71.3%。在回應者中,有 1 304 名視光師 於 2005 年 3 月 31 日在本港視光專業從事經 濟活動\*(在職),而有 48 名據報並非在本港 視光專業從事經濟活動\*(非在本港從事業 內工作)(圖 甲)。



- 1.4 Of the 1 304 active optometrists enumerated, five were seeking jobs, and five reported having temporary sickness during the 30 days before the survey. The survey results presented in paragraph 1.6 below were based on the 1 294 responding optometrists who were practising in the local optometry profession as at 31.3.2005. As certain questionnaires contained missing information, percentages presented below may not add up to 100%.
- 1.5 Of the 48 inactive optometrists, 14 reported practising overseas, six reported practising in the Mainland and 28 reported not practising in the optometry profession in Hong Kong and not seeking job in the local optometry profession during the 30 days before the survey (**Chart A**). Among the 28 inactive optometrists who reported not seeking job, the main reasons reported for not seeking job included: working in other professions (53.6%) and retired (25.0%) (with median age being 66.0 years).
- 1.4 在 1 304 名在職視光師中,在統計日前 30 天內有 5 名正在本港找尋視光專業的工作及有 5 名據報暫時有病在身。下文第 1.6 段所載的統計調查結果,是指截至 2005 年 3 月 31 日,根據 1 294 名在本港從事視光專業的視光師所提供的資料而製備的。由於部分問卷資料不全,下文所載的百分比總和可能不等於 100%。
- 1.5 在 48 名非在本港從事業內工作的視光師當中,有 14 名據報在外地執業,6 名據報在內地執業,5 有 28 名並非在本港從事視光專業工作,而在統計日前 30 天內亦無找尋業內工作(圖甲)。在 28 名非在本港從事業內工作的視光師中,沒有找尋工作主要原因:從事其他行業(53.6%)、退休(25.0%)(其年齡中位數為 66.0 歲)。

- 1.6 Four optometrists did not indicate Of the remaining 1 290 active their sex. enumerated optometrists who practising in the local optometry profession, 1 059 (82.1%) were male and 231 (17.9%) were female, giving an overall sex ratio of 458 (males per 100 females). optometrists did not indicate their age, and the median age of the remaining 1 285 active optometrists enumerated was 41.0 years. The median age of the active female optometrists enumerated was 36.0 years and that of their male counterparts 42.0 years.
- 1.7 The responding active optometrists were requested to indicate the characteristics of their main jobs\*. Distribution by sector showed that a large proportion was working in the private sector (93.4%), followed by those working in the Government, academic and subvented sectors (4.1%), and the Hospital Authority (1.9%). Among the 1 209 active optometrists enumerated who were working in the private sector, the majority were working in optical company / shops (94.5%), followed by those working in medical clinics (2.2%) and private hospitals (1.7%)
- 1.8 The largest median age of the active optometrists enumerated was 41.5 years for those working in the private sector, followed by those working in the Hospital Authority (36.0 years) and those working in the Government, academic and subvented sectors (31.0 years).

1.6 有 4 名視光師沒有註明性別,餘下 1 290 名 在 職 視 光 師 當 中 , 男 性 佔 1 059 名(82.1%),女性佔 231 名(17.9%),整 體性別比率為 458(每百名女性的男性人數)。 扣除 9 名沒有註明年齡的視光師後,餘下1 285 名經點算在職視光師的整體年齡中位數為 41.0 歲。經點算女視光師的年齡中位數為 36.0 歲,而男視光師的則為42.0 歲。

1.7 我們要求作出回應的經點算在職視光師填寫其主要職位\*的特徵。按主要職位所屬機構類型劃分的分布資料顯示,大部分經點算在職視光師在私營機構 (93.4%)工作,其餘依次為政府與學術及資助機構 (4.1%)及醫院管理局(1.9%)。在私營機構工作的 1 209 名視光師中,大部分任職眼鏡公司/店(94.5%),其次為診療所(2.2%)及其他私家醫院(1.7%)。

1.8 經點算在職視光師中,任職私營機構的年齡中位數最大(41.5歲),其餘依次為醫院管理局(36.0歲),以及政府與學術及資助機構(31.0歲)。

- 1.9 Of the 1 294 active optometrists enumerated, 1 153 (89.1%) spent most of their working time in service of optometric care, followed by 54 (4.2%) in administration / management and 11 (0.9%) in research.
- 1.10 The median number of hours of work (excluding meal breaks) per week of the 1 294 active optometrists enumerated was 60.0 hours. 120 (9.3%) optometrists were required to undertake on-call duty in their posts, with a median of 12.0 hours of on-call duty (excluding normal duty) per week.
- 1.11 Of the 1 294 active optometrists enumerated, 43.7% had exemption from the examination\*, 19.8% had certifications<sup>†</sup> issued by the Optometrists Board of Hong Kong and 18.8% held Bachelor's degree.
- 1.12 Of the 1 294 active optometrists enumerated, 308 (23.8%) had received or were receiving additional training, 883 (68.2%) had not received any additional training and 103 (8.0%) did not reveal whether they had received or were receiving additional training or not. Of the 308 active optometrists who had received/were receiving additional training, 43 active optometrists had not yet completed the additional training, 193 (62.7%) held Certificate / Higher Certificate, 20 (6.5%) held Bachelor's degree and 19 (6.2%) held Master's degree.

- 1.9 在 1 294 名在職視光師中,把大部分工作時間用於視光護理的佔1 153 名 (89.1%),其餘依次為行政/管理54 名(4.2%)及研究 11 名(0.9%)。
- 1.10 經點算的 1 294 名在職視光師,每週工作時數中位數(不計用膳時間)為60.0 小時,而 120 名(9.3%)視光師在現任職位中須擔任隨時候召的工作。他們的每週隨時候召工作(不計日常職務)時數的中位數為12.0 小時。
- 1.11 在 1 294 名經點算在職視光師中, 43.7%豁免參加考試\*,19.8%持有由香港視 光師管理委員頒發的證書<sup>†</sup>及 18.8%持有學 士學位。
- 1.12 在 1 294 名經點算在職視光師中,308 名(23.8%)曾接受或正在接受額外訓練,883 名(68.2%)沒有受過額外訓練,而103 名(8.0%)則沒有註明曾否接受額外訓練。在 308 名曾接受/正接受額外訓練的經點算在職視光師中,有 43 名在職視光師還未完成額外訓練,193 名(62.7%)持有證書/高級證書,20 名(6.5%)持有學士學位及19 名(6.2%)持有碩士學位。

- 1.13 Out of the 308 optometrists who had received/were receiving additional training, 172 (55.8%) were trained in one field of additional training; and among them, 71.5% were trained in optometry, 9.3% were trained in optometric research, 8.1% in orthokeratology and 4.1% in contact lens technology.
- 1.14 Regarding Continuing Professional Development (CPD) activities, 475 (36.7%) of the active optometrists revealed that they did not participate in any CPD activities in 2005 and 85 (6.6%) did not reveal whether they had participated in CPD activities or not. Among the 734 active optometrists enumerated who had participated in CPD, the distribution of CPD hours attained in the past 12 months was: one to ten hours (56.8%), 11 to 20 hours (31.7%) and 21 to 30 hours (7.8%).
- 1.13 在 308 名曾接受或正接受額外訓練的在職視光師中,172 名(55.8%)曾接受一項額外訓練,當中曾接受視光學佔 71.5%,視光學研究佔 9.3%,矯視隱形眼鏡技術佔8.1%及隱形眼鏡技術佔4.1%。
- 1.14 關於持續專業發展的活動,475名 (36.7%)在職視光師表示在 2005年並沒有參與任何有關持續專業發展的活動,85名 (6.6%)沒有註明曾否接受有關持續專業發展的活動。至於734名表示曾參與有關活動的在職視光師中,在過去12個月所獲得的時數為:1至10小時(56.8%),11至20小時(31.7%)及21至30小時(7.8%)。


#### II. Trend Analysis

2.1 Since the enactment of the Optometrists (Registration and Disciplinary Procedure) Regulation in April 1996, it is mandatory for a person practising optometry in Hong Kong to hold a valid practising certificate. Between 1996 and 2005, the number of optometrists increased from 1 257 in 1996 HMS to 1 898 in 2005 HMS. On the other hand, comparison of findings of the 2005 HMS with those surveys before 2004 should be cautious as the survey methodology and reference date had been changed (Chart B).

# II. 趨勢分析

2.1 自 1996 年 4 月《視光師(註冊及紀律處分程序)規例》制定後,所有在本港執業的視光師,必須持有有效的執業證明書。在 1996 年至 2005 年期間,視光師的人數由 1996 年統計調查所得的 1 257 名,上升至 2005 年統計調查所得的 1 898 名。然而,由於醫療衞生服務人力統計調查所用的統計調查方法及點算日均已改變,故將 2005 年與 2004 年前統計調查結果比較時必須小心謹慎(圖乙)。

- 2.2 The sex ratio of active optometrists enumerated increased from 524 (males per 100 females) in 1992 HMS to 580 (males per 100 females) in 2000 HMS but decreased to 458 (males per 100 females) in 2005 HMS (**Table A**).
- 2.3 The mean age of the active optometrists enumerated exhibited an increasing trend between 1992 HMS (33.5 years old) and 2005 HMS (42.3 years old).
- 2.4 The proportion of the active optometrists enumerated who were working in the private sector decreased from 97.2% in 1992 HMS to 93.4% in 2005 HMS. On the other hand, the proportion working in the Government, academic and subvented sectors increased from 1.6% in 1996 HMS to 4.1% in 2005 HMS (**Table A**).

- 2.2 經點算在職視光師的整體性別比率,由 1992年統計調查所得的 524(每百名女性的男性人數),上升至 2000年統計調查所得的 580(每百名女性的男性人數),但在 2005年統計調查時則下跌至 458(每百名女性的男性人數)(表甲)。
- 2.3 經點算在職視光師的平均年齡,在 1992年統計調查(33.5歲)至 2005年統計調 查(42.3歲)期間呈上升趨勢。
- 2.4 經點算在職視光師任職私營機構所佔的比例,由 1992 年統計調查所得的97.2%,下跌至 2005 年的 93.4%。政府與學術及資助機構所佔的比例,則由 1996 年統計調查期間的 1.6%,上升至 2005 年統計調查期間的 4.1%(表甲)。
