經點算職業治療師的特徵摘要

Executive Summary

I. Occupational Therapists

Covered

1.1 The occupational therapists covered in the 2008 HMS were occupational therapists registered with the Occupational Therapists Board of Hong Kong under the Supplementary Medical Professions Ordinance (Chapter 359) as at the survey reference date - 31.3.2008.

1.2 The number of occupational therapists covered was 1 255.

1.3 Of the 1 255 occupational therapists covered, 706 had responded to the survey, giving an overall response rate of 56.3%. Among the respondents, 661 were economically active*† (active) in the local occupational therapy profession as at 31.3.2008 and 45 reported to be economically inactive*‡ (inactive) in the local occupational therapy profession (Chart A).

簡要報告

I. 所涵蓋的職業治療師

1.1 2008 年的醫療衛生服務人力統計調查所涵蓋的職業治療師，是指截至調查點算當日(即 2008 年 3 月 31 日)已按《輔助醫療業條例》(第 359 章)的規定，向香港職業治療師管理委員會註冊的職業治療師。

1.2 所涵蓋職業治療師的人數為 1 255 名。

1.3 在統計調查所涵蓋的 1 255 名職業治療師中，有 706 名作出回應，整體回應率為 56.3%。在回應者中，有 661 名職業治療師於 2008 年 3 月 31 日在本港職業治療專業從事經濟活動*†(在職)，而有 45 名據報並非在本港職業治療專業從事經濟活動*‡(非在本港從事業內工作)(圖甲)。

* In the survey, the criteria used in defining economically active / inactive followed those recommended by the International Labour Organization, which are also being used by the Census and Statistics Department in Hong Kong.

是次統計調查中用以界定從事經濟活動及非從事經濟活動的準則，均參照國際勞工組織所提出並獲香港政府統計處所採用的建議。

† “Economically active” occupational therapists comprised all “employed” and “unemployed” occupational therapists. “Employed” occupational therapists referred to those occupational therapists practising in the occupational therapy profession in Hong Kong during the survey period, while “unemployed” occupational therapists referred to those occupational therapists who (a) were not practising in the local occupational therapy profession during the survey period; (b) had been available for work during the seven days before the survey; and (c) had sought work in the occupational therapy profession during the 30 days before the survey. “從事經濟活動”的職業治療師包括所有“就業”及“待業”職業治療師。“就業”職業治療師是指統計調查期間在本港從事職業治療專業的職業治療師，而“待業”職業治療師則指(a)在統計調查期間並非在本港從事職業治療專業；(b)在統計日前 7 天內能夠上班；及(c)在統計日前 30 天內正在本港找尋職業治療專業工作的職業治療師人數。

‡ “Economically inactive” occupational therapists comprised the occupational therapists who were not practising in the occupational therapy profession in Hong Kong during the survey period, excluding those who had been on leave during the survey period and who were “economically active” but “unemployed”. “非從事經濟活動”的職業治療師包括在統計調查期間並非在本港從事職業治療專業的職業治療師，不包括在統計調查期間休假及“從事經濟活動”但“待業”的職業治療師。

1.4 Of the 661 active occupational therapists enumerated, two were seeking jobs and three would start business at subsequent date, expected to return to original job or believed that no work was available in the occupational therapy profession during the 30 days before the survey. The survey results presented in paragraph 1.6 below were based on the 656 responding occupational therapists who were practising in the local occupational therapy profession as at 31.3.2008. As certain questionnaires contained missing information, percentages presented below may not add up to 100%.

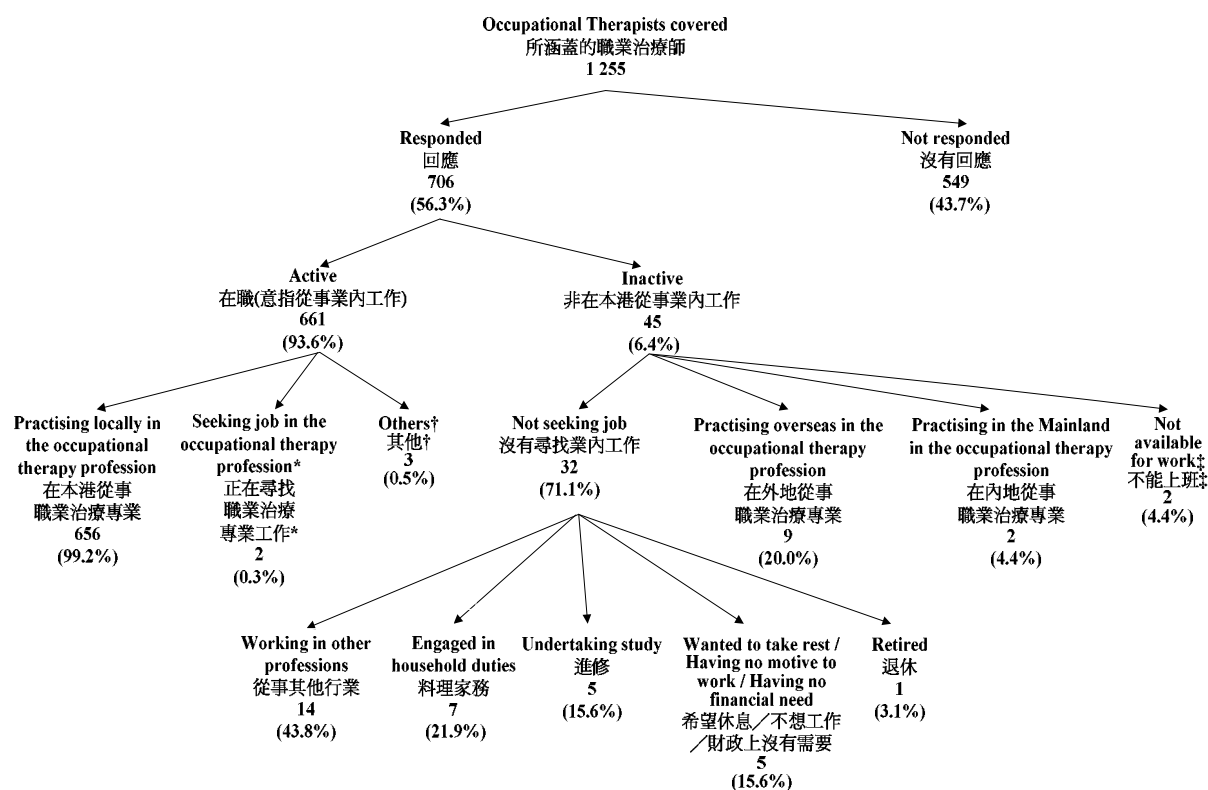
1.5 Of the 45 inactive occupational therapists, nine reported practising overseas, two reported practising in the Mainland and 32 reported not seeking job in the local occupational therapy profession during the 30 days before the survey (**Chart A**). Among the 32 inactive occupational therapists who reported not seeking job, the main reasons reported for not seeking jobs included: 14 (43.8%) were working in other professions, seven (21.9%) were engaged in household duties, five (15.6%) were undertaking studies and five (15.6%) wanted to take rest / having no motive to work / having no financial need.

1.4 在 661 名經點算在職職業治療師中，兩名在統計日前 30 天內正在本港找尋職業治療專業的工作，另有三名即將開展職業治療的生意、期待重返原任職業治療專業崗位或相信職業治療專業工作暫無空缺。下文第 1.6 段所載的統計調查結果，是指截至 2008 年 3 月 31 日，根據 656 名在本港從事職業治療專業的職業治療師所提供的資料而製備的。由於部分問卷資料不全，下文所載的百分比總和可能不等於 100%。

1.5 在 45 名非在本港從事業內工作的職業治療師當中，有九名據報在外地執業、兩名在內地執業及 32 名在統計日前 30 天內無找尋業內工作(圖甲)。而在 32 名非在本港從事業內工作的職業治療師中，沒有找尋工作的主要原因包括：14 名(43.8%)正從事其他行業、七名(21.9%)料理家務、五名(15.6%)進修，以及五名(15.6%)希望休息／不想工作／財政上沒有需要。

1.6 Of the 656 active occupational therapists enumerated who were practising in the local occupational therapy profession, 198 (30.2%) were male and 458 (69.8%) were female, giving an overall sex ratio (males per 100 females) of 43. Apart from one occupational therapist who did not indicate his age, the median age of the remaining 655 active occupational therapists enumerated was 34.0 years. The median age of the active female occupational therapists enumerated was 33.0 years and that of their male counterparts was 36.0 years.

1.7 The responding occupational therapists were requested to indicate the characteristics of their main jobs*. Distribution by sector showed that about half (45.3%) of the active occupational therapists enumerated were working in the Hospital Authority, followed by those working in the subvented sector (39.8%), the private sector (7.6%), the academic sector (4.7%) and the Government (2.6%).

1.8 The median age of occupational therapists enumerated was 44.0 years for those working in the Government, followed by 36.0 years for those working in the Hospital Authority, 31.5 years in the private sector, 30.0 years in the subvented sector and 29.0 years in the academic sector.

1.9 Of the 656 active occupational therapists enumerated, 87.7% spent most of their working time in rehabilitation, followed by 8.4% on administration / management, 1.8% on teaching and 1.7% on research.

1.6 經點算的 656 名在本港從事職業治療專業的在職職業治療師中，198 名(30.2%) 為男性，458 名(69.8%)為女性，整體性別比率(每百名女性的男性人數)為 43。除了一名職業治療師沒有註明年齡外，餘下 655 名經點算在職職業治療師的整體年齡中位數為 34.0 歲。女職業治療師的年齡中位數為 33.0 歲，而男職業治療師的年齡中位數則為 36.0 歲。

1.7 我們要求作出回應的職業治療師填寫其主要職位*的特徵。按主要職位所屬機構類型劃分的分布資料顯示，約有一半(45.3%)經點算在職職業治療師在醫院管理局工作，其餘依次為資助機構(39.8%)、私營機構(7.6%)、學術機構(4.7%)及政府(2.6%)。

1.8 任職政府的經點算職業治療師年齡中位數為 44.0 歲，其餘依次為醫院管理局(36.0 歲)、私營機構(31.5 歲)、資助機構(30.0 歲)及學術機構(29.0 歲)。

1.9 在 656 名經點算在職職業治療師中，87.7%把大部分工作時間用於康復治療，其餘依次為行政／管理(8.4%)、教學(1.8%)及研究(1.7%)。

* Main jobs referred to the jobs in which the occupational therapists had spent most of their working time.

1.10 The median number of hours of work (excluding meal breaks) per week of the 656 active occupational therapists enumerated was 44.0 hours. Among them, 636 (97.0%) did not require to undertake on-call duty (excluding normal duty) and 17 (2.6%) were required to undertake on-call duty, with a median of 2.0 hours of on-call duty (excluding normal duty) per week.

1.11 Of the 656 active occupational therapists enumerated, most held Bachelor's Degree (64.2%) and 34.9% held Professional Diploma as their basic qualifications.

1.12 Of the 656 active occupational therapists enumerated, 477 (72.7%) received / were receiving additional training and 179 (27.3%) did not receive any additional training. Of the 477 active occupational therapists with additional training, 27 (5.7%) active occupational therapists had not yet completed the additional training, 305 (63.9%) held Master's Degree, 68 (14.3%) held Certificate and 33 (6.9%) held Post-graduate Diploma.

1.13 Of the 477 occupational therapists who received / were receiving additional training, 411 (86.2%) were trained in one field of additional training. Among them, 37.5% were trained in health care (occupational therapy / rehabilitation technology), 24.1% were trained in rehabilitation sciences / studies, 13.1% in health care management / health services management, 8.0% in counselling and 3.6% in gerontology.

1.10 經點算的 656 名在職職業治療師當中，每週工作時數(不計用膳時間)的中位數為 44.0 小時。636 名(97.0%)不用擔任隨時候召工作(不計日常職務)及 17 名(2.6%)職業治療師需作隨時候召工作，而每週隨時候召工作(不計日常職務)時數的中位數為 2.0 小時。

1.11 在 656 名經點算在職職業治療師中，64.2%持有學士學位，及 34.9%持有專業文憑作為基本資格。

1.12 在 656 名經點算在職職業治療師中，477 名(72.7%)曾接受／正接受額外訓練，179 名(27.3%)沒有受過任何額外訓練。在 477 名有接受額外訓練的在職職業治療師中，27 名(5.7%)還未完成額外訓練，305 名(63.9%)持有碩士學位，68 名(14.3%)持有證書及 33 名(6.9%)持有深造文憑。

1.13 在 477 名曾接受／正接受額外訓練的職業治療師中，411 名(86.2%)曾接受一項額外訓練。當中，37.5%人士接受健康護理(職業治療／康復技術)訓練，康復科學／研究佔 24.1%、健康護理管理／衛生服務管理佔 13.1%、輔導佔 8.0%及老年學佔 3.6%。

1.14 Regarding Continuing Professional Development (CPD) activities, 517 (78.8%) of the active occupational therapists revealed that they had participated in CPD activities in 2008, 94 (14.3%) did not participate in any CPD activities and 45 (6.9%) did not reveal whether they had participated in CPD activities or not. Among the 517 active occupational therapists enumerated who had participated in CPD activities, the distribution of CPD credits attained in the past 12 months was: 1 to 10 credits (28.4%), 11 to 20 credits (35.6%), 21 to 30 credits (16.1%), 31 to 40 credits (5.2%) and more than 40 credits (14.7%).

1.14 關於持續專業發展的活動，517名(78.8%)在職職業治療師表示在2008年曾參與有關持續專業發展的活動，94名(14.3%)並沒有參與任何有關持續專業發展的活動及45名(6.9%)沒有註明曾否參與任何有關持續專業發展的活動。至於517名表示曾參與有關活動的在職職業治療師中，在過去12個月所獲得的學分為：1至10學分(28.4%)、11至20學分(35.6%)、21至30學分(16.1%)、31至40學分(5.2%)及多於40學分(14.7%)。

II. Trend Analysis

2.1 Comparison of findings of the 2008 HMS with those surveys before 2004 should be cautious as the survey methodology and reference date had been changed.

2.2 Since the enactment of the Occupational Therapists (Registration and Disciplinary Procedure) Regulations (Chapter 359B) in August 1991, it is mandatory for a person practising occupational therapy in Hong Kong to hold a valid practising certificate. Between 1992 and 2008, the number of occupational therapists increased from 470 to 1 255 (Chart B).

II. 趨勢分析

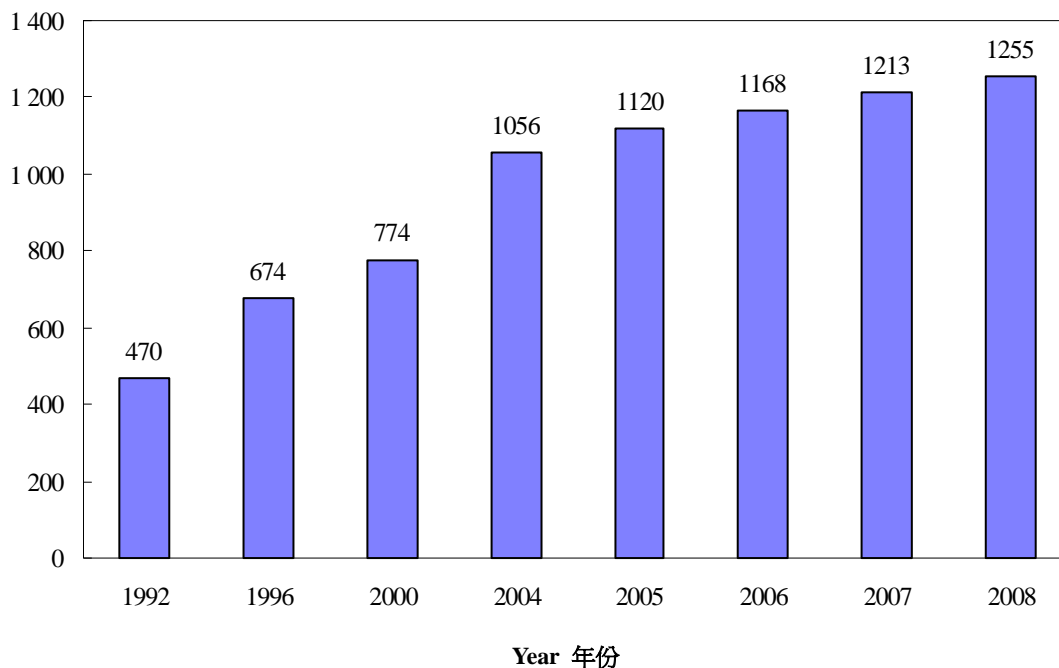
2.1 醫療衛生服務人力統計調查的統計調查方法及點算日均已改變，故將2008年與2004年以前的統計調查結果比較時必須小心謹慎。

2.2 自1991年8月《職業治療師(註冊及紀律處分程序)規例》(第359B章)制定後，所有在本港執業的職業治療師，必須持有有效的執業證明書。在1992年至2008年期間，職業治療師的人數由470名上升至1 255名(圖乙)。

2.3 Since 1982, the sex ratio (males per 100 females) of active occupational therapists enumerated has been fluctuating in the range between 39 and 58. The sex ratio (males per 100 females) in 2008 was 43 (Table A).

2.4 The mean age of the active occupational therapists enumerated increased gradually from 28.2 years in 1982 to 34.9 years in 2008.

2.5 From 1982 to 1990, the largest proportion of active occupational therapists enumerated was working in the Government, followed by the academic and subvented sectors, which together employed more than 80% of all the occupational therapists. The Hospital Authority has been the largest employer since its setup in 1991, while the proportion of active occupational therapists employed in the Government decreased to less than 5%. The proportion working in the academic and subvented sectors increased from 16.5% in 1982 to 44.5% in 2008.

2.3 自 1982 年，經點算在職職業治療師的性別比率(每百名女性的男性人數)介乎 39 至 58。而 2008 年的性別比率(每百名女性的男性人數)為 43 (表甲)。

2.4 經點算在職職業治療師的平均年齡，由 1982 年的 28.2 歲，逐漸上升至 2008 年的 34.9 歲。

2.5 在 1982 年至 1990 年期間，經點算在職職業治療師以任職政府的比例最多，其次為學術及資助機構，兩者合共聘用多於 80% 的職業治療師。醫院管理局自 1991 年成立以來，已成為最大的僱主，而政府所聘任的職業治療師的比例則下降至少於 5%。任職學術及資助機構所佔的比例，則由 1982 年的 16.5%，上升至 2008 年的 44.5%(表甲)。
